UPDATED TIMETABLE – RENOUNCEABLE RIGHTS ISSUE AND CLARIFICATION OF ASX ANNOUNCEMENT RELEASED 15 JANUARY 2025

Macarthur Minerals Limited (ASX: MIO) (the **Company** or **Macarthur**) provides an updated indicative timetable for its pro-rata renounceable entitlement offer to raise up to approximately A\$2 million (Offer), originally announced on 23 May 2025 and previously updated on 2 July 2025 and 7 July 2025.

The revised timetable provides additional time for shareholder participation and follows ongoing regulatory review by ASIC of the Company's Supplementary Prospectus.

Clarification of ASX Announcement Dated 15 January 2025

The Company wishes to clarify a statement made in its ASX announcement titled "Clarification Announcement", released on 15 January 2025.

That announcement stated:

"As per the binding agreement signed between Macarthur Minerals and Gold Valley Yilgarn Pty Ltd on 13 June 2024, Gold Valley is in the process of securing all the necessary mining approvals for the Lake Giles Moonshine Magnetite Project."

This reference was incorrect. It should have stated:

"...securing all the necessary mining approvals for the Lake Giles Hematite Project."

The 13 June 2024 binding agreement between Macarthur and Gold Valley, as announced on that date, relates solely to the Hematite Project. The reference to the Moonshine Magnetite Project in the 15 January 2025 announcement was made in error.

Company profile

Macarthur is an iron ore development, and lithium exploration company that is focused on bringing to production its Western Australia iron ore projects. The Lake Giles Iron Project mineral resources include the Ularring hematite resource (approved for development) comprising Indicated resources of 54.5 million tonnes at 47.2% Fe and Inferred resources of 26 million tonnes at 45.4% Fe; and the Lake Giles magnetite resource of 53.9 million tonnes (Measured), 218.7 million tonnes (Indicated) and 997 million tonnes (Inferred). The Lake Giles Iron Project also contains Proven Ore Reserves of 51.9 Mt and Probable Ore Reserves of 184.7Mt. Macarthur also holds 24 square kilometre tenement area iron exploration interests in the Pilbara region of Western Australia. The Mineral Resource and Ore Reserve estimates presented herein have previously been released to the ASX on March 21, 2022, including supporting JORC reporting tables. The Company confirms that it is not aware of any new information or data that materially affects the information included in the relevant market announcements and, in the case of Mineral Resources and Mineral Reserves that all assumptions and technical parameters underpinning the estimates in the relevant market announcement continue to apply and have not materially changed.
