8.8.1	Does the entity expect that it will continue to have the current level of net operating cash flows for the time being and, if not, why not?	
	Answer: No. Net operating cash outflows for the current quarter were higher than the Company expects to incur on an ongoing basis. This was mainly due to one-off payments of outstanding liabilities following completion of the placement during the quarter. As those payments are not expected to recur at the same level, the Company expects its net operating cash outflows to reduce in future quarters.	
8.8.2	Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?	
	Answer: Yes. The Company will continue to monitor its working capital requirements and, if required, intends to seek additional funding available funding arrangements. The Company may also receive royalty revenue under its existing commercial arrangements. However, the timing will depend on the commencement and level of future production. The Company is not relying solely on royalty revenue to fund its operations. Having regard to the A\$1.25 million placement completed during the quarter and the Company's previous access to equity capital markets, the Board considers that the Company has reasonable prospects of securing additional funding if required. Any future funding will remain subject to market conditions and there can be no assurance that funding will be available on acceptable terms or within the required timeframe.	
8.8.3	Does the entity expect to be able to continue its operations and to meet its business objectives and, if so, on what basis?	
	Answer: Yes. The Company expects to be able to continue its operations and meet its business objectives through its existing cash resources, continued management of expenditure, potential royalty revenue and if required, additional funding through available funding arrangements. The Company will continue to manage the timing and scope of its discretionary expenditure having regard to its available cash resources and funding position.
